### Purposes of processing

### Legal basis processing

CodeLogic CRM processes your personal data on the following legal basis:

### **Retention of personal data**

CodeLogic c CRM uses the following criteria to determine the period for which your personal data will be stored:

- During the period of frequent (at least once every 12 months) contact (physical, telephone, email).
- For as long as CodeLogic CRM has an agreement with your person or with the organization for which you work.
- For 5 years after an agreement entered into by CodeLogic CRM with your person or with the organization for which you work has ended.

### **Data subjects' rights**

You have the right to submit a request to us to inspect, correct and/or delete the personal data we process about you. In addition, you have the right to request us to restrict the processing of your personal data and to object to the processing of your personal data.

As a data subject, you also have the right to request CodeLogic CRM to recover the personal data that you yourself have provided to CodeLogic CRM in a structured, common and machine-readable form, so that you can provide this personal data to another data controller if you wish.
